FINANCIAL POLICY

Thank you for choosing Colorado Valley Veterinary Services. Our primary mission is to deliver the best and most comprehensive veterinary care available for your pets or livestock. An important part of the mission is making the cost of optimal care as easy and manageable for our clients as possible by offering several payment options. Colorado Valley Veterinary Services requires payment in full at the end of your pet or livestock's examination and/or at the time of discharge. Charging privileges must be pre-approved by the business manager and credit application must be completed.

Payment Options:

Deposit & Billing

For some treatments or hospitalized care, a deposit may be required. Healthcare plans requiring comprehensive care of \$300 or more, will require a 50% deposit to begin your pet or livestock's treatment. We charge 1.5% interest on all outstanding account balances older than 30 days. If you have an account 90 days past due, Colorado Valley Veterinary Services may relinquish your balance owed to a collection agency. By signing you agree to reimburse us the fees of any collection agency, which may be based on a percentage at a maximum of 30% of the debt, and all costs, and expenses, including reasonable attorneys' fees, we incur in such collection efforts.

Additional Policy Information

Colorado Valley Veterinary Services charges \$30 for returned checks. For clients with pet insurance, we are happy to provide you with the necessary documentation to submit a claim to your insurance carrier.
